"That Kilkenny County Council undertake a survey with a view to undertaking and supplying paths ways on the Dunningtown Rd."

6 (23) Cllr. Andrew McGuinness

"That this Municipal District would assess the condition of the steps leading from Lacken Drive to O'Loughlin Road with a view to resurfacing the steps and taking preventative measures to help prevent pedestrians from slipping, provide a costing and a timeframe so it can be considered by the elected members."

"That this Municipal District would engage with the developers and residents of Parcnagowan, Kilkenny, to help speed up the taking in charge process and address the issues that have arisen in recent years including serious difficulties with rain water drainage that has resulted in some residents' homes being flooded, and the presence of a large sink hole in the green area".
